R & T Event Assistance Program

The Recreation & Transportation (R & T) Committee sponsors a Program called the R & T Event Assistance Program. The goal of this Program is to foster the development of province wide recreational cycling events by providing funding to clubs to assist with the financing of approved events.

Who may apply:

• Clubs who are members of the Saskatchewan Cycling Association (SCA).

Assistance available:

• Assistance will be calculated at \$10/day for first 15 participants and the remaining participanst will be \$5/day to a maximum of \$1500.

Eligibility:

Events must include participants from at least 2 (two) different Sport, Culture and Recreation Districts* in Saskatchewan.

- If 2 districts are not represented rational must be provided in follow-up
- Events or participation in events already funded by SCA such as GASP do not qualify.
- Events which the club uses MAP Grant funds to cover the full cost of expenses do not qualify. Note: if MAP
- Grant funds do not cover the full cost of the event, the remaining expense would qualify for this Grant.
- Annual events and new events are eligible.
- Multiple applications from the same club are acceptable but the subsequent events will be considered a lower priority.
- Clubs must have a good record of follow up and reporting on such events. Clubs must be represented at the AGM.

Application Review

- · R & T Event Assistance Applications must be submitted to the R & T Committee by June 1st.
- R & T committee will approve applications by June 20th.
- · When the R & T Committee reviews the Plans and there are more plans than funds available, the Committee will rate the Plans giving a hirer priory to:
 - `new events and or
 - ` annual events revised to encourage new members

Payment Procedure

- A cheque for the first 60% of each approved funds will be issued by June 30th of each funding year.
- The final 40% of approved funding will be paid out to a club once that club has submitted a follow up report, including appropriate receipts and/or documentation and the follow-up report is approved by the the R & T committee.

Ineligible expenses:

- · Any construction, upgrading, maintenance or operating costs of facilities
- Expenditures for which other grant dollars have been used. Two different grants cannot be used to pay the same dollar of expense, whether the grant comes from the SCA or any other granting agency.
- Cash Prizes
- Social event
- Alcoholic beverages
- Research projects & feasibility studies
- Out-of-Province travel
